Welcome from our Chair

This is the last report that I write as Chair of the Trustee Board and over the last 33 years there have been some changes. When I was first appointed mobile phones did not exist, computers were not in use and our poor County Secretary had to 'Roneo' copies of papers and send them out by post. Bank accounts were established by a meeting with the Bank manager and Scout numbers in Cheshire were about 8,000 and no girls. This puts into perspective where we are now and where we are going and how we must work with the tide of progress. Today we all carry a mobile phone, have a laptop or a home computer and probably a photocopier too. Bank accounts can be online. The local bank manager is no longer local, and proof of I.D. is always required. Entry into Scouts now can start at Squirrel or Beaver age and not just at Cubs and girls make up a significant element of Scouting. In recent years and brought forward by COVID the ability to chat and meet online has opened opportunities previously thought to be impossible. In Cheshire your Board has held meetings online and in situ but always with a link there for those that are unable to attend in person. The magician is your Treasurer, Luke Thornton, who continues to work as Treasurer and attends meetings even when he is on the other side of the world. In the past three years he has tidied up the accounts and put systems in place that has made budgeting, forecasting and accounting simpler and more effective. However, we still need dedicated people in situ as exemplified by the volunteer Activity Centres manager, Luke Morby. The two Lukes make a great team. Both are part of the wave of young

scouters brought on by Graham Phillips and Dave Hopley. Another such individual is Michael Rollinson, Deputy Chair who is to take over as Chair. Both Michael and I share the link to Baden-Powell who, in 1904, was invited to officially open the Salford Lads' Club. My greatgrandfather may have invited him, and my grandfather was there too. It is obvious that it was the camping expeditions of the Salford Lads' Club that sewed the seed for Baden-Powell to trial a camp on Brownsea Island 3 years later in 1907 and so (belatedly) start the Scout movement. Michael is a member of the Salford Lad's Club thus Cheshire retains its link to Scouting 3 years before scouting began.

Looking at last year, we were able to change our structure in line with The Charities Commission's by following the revisions made in April of the Scouts' Policy Organisation and Rules (POR) and include them at our Annual General Meeting last June. This resulted in a smaller and more effective 'Board of Trustees' reflecting the role of the board which is 'governance'. The term 'Commissioner' was replaced by 'Lead Volunteer'. The year started with six months as the 'Executive Committee' and finished with six months as the 'Board of Trustees'. It continued to meet on a bi-monthly basis and was supported by the Finance Committee and the Activities Centre committee. The dynamic of the County, as ever came from our County Lead Volunteer, Dave Hopley. He has been able to get the right people in place to support him and continually looks for opportunities to take Cheshire forward and have our young scouters involved. Roverway and the World Scout Jamboree were big events, and the latter was brought back from the brink of disaster with the concerted efforts by all involved. The King's coronation was an opportunity for

selected scouts from Cheshire to be involved and what a privilege for them. Safety in scouting remains paramount and we are fortunate to have John Duley to oversee that the Safety and Safeguarding training is up to date. Cheshire hike, finally, in its new format, was a great success. The ability to see the opportunity, apply for and succeed in the Grant application for 2 Development Officers worth a total of £221,000 over two years is to be congratulated. With new members in the Activity Centres Committee and new financial systems now in place and an onsite presence, maintenance and repair are now on a planned basis with better budgeting. Significant tasks such as the repair of the Climbing Wall, and The Begg Building have been undertaken. The installation of an adequate waste treatment system is closer, but the access issue is stalled awaiting a response from Cheshire West. In Cheshire East we are still waiting for the conclusion of our lease at Tatton. At the end of the year after 20 years Cathy Bland stepped down from her role as County Administrator. Sam Davies has taken over with a larger remit. We thank Cathy for all the work she has done and wish Sam all the best in her new role. The year finished with increased Scout numbers and a significant increase in income over 2022. The projected deficit was less than forecast at £7,719 and an excellent achievement considering the additional works carried out. Our reserves remain strong and bearing in mind unforeseen accidents and pandemics we need to keep them strong. Next year we are forecast for a similar result. I thank you all for everything you have done over the last thirty-three years in my term as Chair. I wish you all in Cheshire every success for the future.

A year of achievement

Each year I look back with nothing but pride at what we've achieved together. This year, I truly believe we've more to be proud of than ever.

Cheshire Scouts recorded a further 3% growth in youth membership this year, with over 304 young people and 65 adult leaders joining our 12,668-strong movement.

Just two years ago, Squirrels – the section for 4-6 year olds – was launched, and this year we've opened another 12 Squirrels Dreys across the County, giving us a total of 21, with another 7 planned for 2024 so far.

We've secured funding to support our ambitious Inclusive Growth Plan, recruiting two full-time Local Growth Officers to help us open more than 40 new sections in under-represented communities over the next two years.

We were awarded Charity of the Year 2023 by The Cheshire and Warrington Pledge for Chamboree – our international Scout and Guide Jamboree.

Our annual Cheshire Hike event in April was a sell-out, with over 700 Scouts and Explorers taking part. Whilst 275 Cub Scouts slept under the GAIA Earth Artwork at Chester Cathedral. We opened our Skills Day out to Young Leaders, with over 120 taking part.

We had our first ever Cheshire 'King's Scouts on Parade' at Windsor this St. George's Day. Over 560 Scouts and Explorers were awarded top awards at our Celebrating Success event this autumn, including 60 Explorer Belts, 130 You Shape Awards. The High Sheriff of Cheshire also made special awards to our Explorer Belt and World Scout Jamboree adult leadership teams in celebration of our global summer.

Over 100 Cheshire Scouts and leaders had an unforgettable experience out in South Korea for the 25th World Scout Jamboree. Despite the hurdles, our Scouts broadened their horizons and showed incredible adaptability, while exploring the cultural heritage of South Korea during the once-in-a-lifetime experience.

In addition, our Explorer Belt contingent of 60 Explorer Scouts and Scout Network members had an amazing two-week European international expedition this Summer, with teams traveling across Belgium, the Netherlands and Germany.

We held two successful Community Impact Days at Tatton Park for under-represented communities, and children in foster care, as well as 24 'Big Help Out' events across our 9 Districts for the King's Coronation.

I am really excited to have appointed Dan Skinner as the next as Youth Lead for Cheshire Scouts, a role designed to ensure young people are empowered to share their ideas and have a meaningful voice, getting them involved and engaged in our decision making.

Dan said, "I can't wait to get out and meet as many young people as I can and get them engaged in everything we do. Young people have brilliant ideas and talent that can drive Scouting forward and. drive growth. Let's inspire and support our youth – to shape their own adventure!".

Scouts is a team game, and everyone plays their part. Thank you for all you do, making Scouts open to all, supporting our young people, and most of all, looking out for each other, as we continue to transform our volunteering experience and help more young people gain the skills, they need to shine bright.

Our purpose and method

Cheshire Scouts actively engages and supports young people in their personal development, empowering them to make a positive contribution to society.

In partnership with adults, young people take part in fun indoor and outdoor activities. They learn by doing, by sharing in spiritual reflection and by taking responsibility. They make choices, undertake new and challenging activities, and they live their Scout Promise.

Cheshire Scout's Trustees have a duty to report on our public benefit in this Annual Report. We've assessed our aims, activities and charitable objectives, which are to contribute to the development of young people in achieving their full potential as individuals, as responsible citizens, and as members of their local, national and international communities. We believe that we've met the Charity Commission's public benefit criteria for both the advancement of education, and the advancement of citizenship and community development.

Cheshire Scouts follows 2 key principles set by the Commission with regard to public benefit:

In our Skills for Life Strategy, we aimed to prepare more young people with skills for life, supported by amazing leaders delivering an inspiring programme. We talked about growing, being more inclusive, being shaped by young people and making a bigger impact in our communities.

1. Identifiable benefit

The way in which we help young people in their personal development and empowers them to make a positive contribution to society. This benefit is directly linked to the purpose of Cheshire Scouts.

2. Public benefit

Cheshire Scouts is a county wide movement, open to young people aged 6-25 and adults who are willing to make the Scout Promise. People in areas of deprivation are able to benefit from our programme; while we charge a subscription to our members, access to our benefits aren't constrained by a member's ability to pay. There are arrangements to waive subscriptions and other costs for those who face financial hardship, so that young people aren't excluded from Scouts on purely financial grounds.

The benefits of Scouts are further demonstrated throughout this report.

In 2023, the Programme team had an eventful and rewarding year. In February we hosted the second successful Programme Forum, inviting all Programme Team members from across the County to represent their sections and districts. This opportunity allowed for networking with their equivalents from across all Districts of Cheshire. It was particularly successful due to the network-style of the event which gives volunteers the chance to meet with others to share best practice, problem solve and share new ideas.

Our biggest news from last year is the international events which went on over Summer. Cheshire had 72 young people represent Cheshire at the 25th World Scout Jamboree in Korea, and 62 young people complete their Explorer Belt as part of the County's first led expedition, the challenge of a lifetime. We also held a Roverway selection day, concluding with a Cheshire Patrol attending the Roverway 2024 in Norway.

Bringing success, a little closer into the County we have built up our Squirrel Dreys across the County with support from Mel, our Squirrel Section Lead in the Programme Team, looking to create a Squirrel County Event in 2024. Beavers Skills Challenge and the Cubs Craft Challenge held their annual County Competition, with the Scout section following in suit with their return of the Scout Patrol Challenge, held at Forest Camp. All these events consist of District Rounds, before the winning patrols compete at County level for the title, highlighting the talents and achievements of young scouts across Cheshire.

We also hosted the biggest Cheshire Hike to date, with over 700 hikers, held County Climbing Events for Cubs, Scouts and Explorers, and facilitated over 275 Cubs sleeping under the GAIA at Chester Cathedral.

In 2023, over 560 individuals earned their Top Awards, with 200 young people earning their Chief Scout Award, 80 Explorer Scouts achieving their Chief Scout's Platinum and Chief Scout's Diamond Awards, and 70 young leaders earning belts. Additionally, 133 received YouShape awards, and 8 had achieved their BTEC awards. We also celebrate the 14 recipients of the King and Queen's Scout Award, the highest recognition. As we continue to focus on progressive and sustainable growth, the Programme Team remains dedicated to delivering impactful programs and initiatives for all sections. We extend our support to Districts, Groups, and Units on the ground, and we are looking forward to another amazing year ahead!

Volunteering Development

A Group Lead Volunteer's Day was held in March with Scout HQ staff giving details of the Transformation and Development programme that will make volunteering easier and support managers in reducing administration work, together with information about the new on-line system.

The census showed a 3% increase in Adult volunteers including 93 front-line leaders meaning that Cheshire can offer scouting to even more young people.

Delighted to welcome 3 new District Lead Volunteers for Mid-Cheshire, Warrington East and Warrington West.

Tim Owen and Richard Johnson became the County Learning Team Leaders and have worked tirelessly to ensure that leaders can complete their training by delivering 62 faceface or online courses throughout the year. 115 Wood Badges were completed, over 520 First Response validations completed, and they also validated 2,500 Wood Badge modules (highest ever). They have also had the excellent support of the District Learning Team leaders. Neil McAleece was appointed to lead the County Activities Team (with Pete Goodger as his Deputy) and they have reviewed the Assessors and refreshed the programme of training and assessment. Various activity permit training courses have been organised throughout the year meaning we have many more leaders gaining their hillwalking, climbing, rafting, bell-boating, shooting, archery and off-road biking permits. This, of course, means more adventurous activities for the young people.

Over 100 leaders attended the County Skills Training Day in at Forest Camp in September with 120 Young Leaders attending the NEW Skills Day aimed at teaching them skills that they could take back into their group.

2 of our leaders – Carol Frain and Oli Chambers were invited to attend a Buckingham Palace Garden Party whilst 6 other leaders were invited to attend the Coronation Concert in Windsor – an honour for all. Pleased that many volunteers have been recognised for their service to Scouting by receiving Good Service Awards – many of them being presented at the County Scout Dinner held in March. High Sheriff Awards were presented to the Team Leaders of the World Scout Jamboree and the Explorer Belt expedition.

Support

Transformation and Change

During 2023 across the county there was a range of work to prepare for the changes that the Association is adopting following considerable consultation within and outside of the movement.

Some of the key drivers being the need to replace the ageing Compass Adult membership system and to reduce the administrative workload

on managers at all levels Introduce new learning material and processes to reflect current developments in making scouting a safe and rewarding experience for its members of all ages.

Introduce a new way of welcoming new volunteers that will replace the current Appointments process.
Introduce a flexible and easy to use adult management system that will be easily accessible across computer, tablets and mobile devices.

To align our Trustee boards with current Charity Commission regulations and recommendations This work was undertaking in line with an original delivery date of the new management system of early 2024. This system supports a range of the changes detailed above specifically the learning and the welcome process.

Implementation has now been delayed as while the Digital System has been built the complex process to migrate data from Compass requires further work.

We will therefore continue to prepare for its delivery which could now be later this year.

My thanks to all who have put so much work into preparation for these changes. And look forward to the benefits we will see from these changes.

The shortlist of Chamboree themes was made, and we put it out to all Cheshire Scout members to vote. Lots of other exciting topics were discussed, along with actions to be taken in 2024.

After the Youth Forum, I attended Progfest with Charly and Amelia. It was brilliant to learn more about the programme and discuss how to get young people involved. At our strategy weekend in November, I spoke to the County Team, sharing the vision for how we support young people and engage and involve them in everything we do. I met all the District You Leads; it was great to discuss how we can work together and champion young people. In January, a District Youth Lead was appointed in Warrington East, meaning all nine of our districts had a Youth Lead—something to be proud of. 2024 is an exciting year with many Youth Forums planned, including taking them to the road to engage as many young people as possible. The Youth team can't wait to champion and engage young people; together, let's help young people across Cheshire shape their own adventure.

Despite the hurdles, Scouts broadened their horizons and showed incredible adaptability while also exploring the cultural heritage of South Korea during the once-in-a-lifetime Jamboree.

In addition, our Explorer Belt
Contingent of 60 Explorer Scouts
and Scout Network members (9
Explorer Scout Teams, and 4
Network Teams) and their Mentors
had an amazing two-week
European international expedition
this Summer. With teams traveling
across Belgium, The Netherlands
and Germany. Major projects
included: Cultural and culinary
diversity; Comparison of public
transport systems; How historical
events, including World War II have
impacted culture, and more.

All Explorer Belt participants will receive their Explorer Belt Awards at Celebrating Success on 5th November. In addition, both our Explorer Belt contingent members and World Scout Jamboree unit members will receive their You Shape Awards which they have gained as part of their programme.

There is a great legacy from this Summer with participants articulating the skills they've gained in independence, confidence, resilience, organisation, communication and teamwork, with many now inspired toward either their King's Scout Award, Scouts of the World Award, doing another independent expedition/international travel, and some of whom were keen to volunteer to Mentor future Explorer

Belt participants or join an International Service Team.

Our adult volunteers were recognised with a special award being made by High Sheriff of Cheshire, Dr Dennis Dunn MBE JP DL for our Explorer Belt leadership team, in recognition of the training and mentorship they gave to our 13 teams of Scouts undertaking their expeditions across Europe this Summer. Dennis also made a special award to the 8 leaders who led Cheshire Scout's contingent of 72 young people to the World Scout Jamboree in Korea this Summer, following a two-year training journey, for their determination and resilience in the face of adversity, ensuring young people were prepared and had an exceptional World Scout Jamboree in Korea.











How we operate

Cheshire County Scout Council's 'Cheshire Scouts' governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

The County is a Trust established under its rules which are common to all Scouts.

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

The County is managed by the Trustee Board, the members of which are the 'Charity Trustees' of the Scout County which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Trustee Board consists of 2 exofficio members, the County Lead Volunteer and County Youth Lead; 2 appointed officers, the County Chair and County Treasurer; together with and up to 6 appointed members and up to 2 members co-opted by the Trustee Board. The Board typically meets every 2 months (6 times per year).

Members of the Trustee Board complete 'Essential Information for Trustee Boards' training within the first 5 months of joining the committee.

The County Trustee Board is a team of volunteers who work together, as charity Trustees, to make sure Cheshire Scouts is run safely and legally. At the heart of their role is a focus on strategy, performance, and assurance. They are responsible for:

- Protecting and maintaining any property and equipment owned by and/or used by the County.
- Managing the County finances.
- Providing insurance for people, property, and equipment.
- Promoting and supporting the development of Scouting in the local area.
- Ensuring that a positive image of Scouting exists in the local community.
- Appointing and managing the operation of any sub-Committees.
- Ensuring that Young People are meaningfully involved in decision-making at all levels within the County.

Risk and Internal Control

The County has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include 2 signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

The Trustee Board has identified the major risks to which they believe the County is exposed, these have been reviewed and systems have been established to mitigate against them. The principal areas of concern that have been identified are:

Damage to building, property and equipment

The County has sufficient buildings and contents insurance in place to mitigate against permanent loss.

Injury to leaders, helpers, supporters, and members

The County through the capitation fees contributes to the Scout Association's national accident insurance policy. Risk Assessments are undertaken before all activities.

Reduced income

The County is primarily reliant upon income from subscriptions. The County does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the County on an ongoing basis, either temporarily or permanently.

Reduction or loss of leaders

The County is reliant upon volunteers to run and administer the activities of the County, its Districts and Groups. If there was a reduction in the number of leaders to an unacceptable level there would have to be a contraction, consolidation or in the worst-case scenario closure.

Reduction or loss of members

The County provides activities for all young people aged 4 to 18. If there was a reduction in membership in a particular District or Group then there would have to be a contraction, consolidation or in the worst-case scenario closure.



Our Finances

Cheshire Scouts' financial statements have been prepared in accordance with the Statement of Recommended Practice, (Accounting and Reporting by Charities) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Ireland, FRS 102, known as the Charities SORP (FRS 102), and the Charities Act 2011.

Reserves Policy

The County's policy on reserves is to hold sufficient resources to continue the charitable activities of the County should income and fundraising activities fall short. The Trustee Board considered the normalised expenditure from one year to the next, excluding the impact of Chamboree, and used 6 months of expenditure as a starting point for their analysis. This showed a c.£150k requirement for the reserves. In addition to this, the Trustees considered the additional impact of Chamboree on the charity. They therefore calculated a 25% expenditure overrun, based on a gross budget of £500k, and established an additional reserve of £125k. This gives a total reserves requirement of £275k. To be prudent, the Trustees evaluated a reasonable ongoing minimum reserves position of £300k. This clearly leaves headroom above the £579k unrestricted reserves position currently. The Board therefore are looking to utilise this additional headroom, by doing the following:

 Investing an amount of the additional resources, via the Board's investment policy Looking to create a managed deficit in the year, via investing in the long-term development of the charity through growth initiatives and supporting large events (e.g., Chamboree & Jamboree).

The board are also actively considering how access to additional funds, for example through grants, can support Cheshire Scouts through activity centres and accessibility to accelerate our growth, and this is viewed to be in the long-term financial interest of the Charity.

Investment Policy

The Trustee Board takes a proactive approach to its financial position. In doing so, when there are surplus reserves above that which will be required over the short to medium term, the Trustees will look to allocate it to areas which will benefit the longterm health of the charity, be that in the level of activity through investing in the development of the charity, or into financial investments to generate a long-term financial return to the charity. The Trustees have the authority to allocate the financial resources as it sees fit to further the charitable endeavours of the charity. The charity's investment objectives are to generate a return on the financial assets of the charity, so that its resources continue to keep pace with inflation and ideally generate a return above inflation.

The charity's approach to risk is as follows:

- To ensure the charity's resources are appropriately diversified across asset classes, when considering all the financial resources of the charity.
- To invest over a sufficient timeframe so to achieve higher returns and be able to weather out any shorter-term downturns in the market.

- To invest in funds with specified strategies/ trackers, rather than specific stocks or bonds, to ensure that we are utilising fund managers and strategies broader than the charity.
- To invest with reputable and respected investment managers, to safeguard the charity's assets and reputation.
- To ensure that our funds are not held with a single institution, to protect us from concentrated credit risk.

Our Finances

Independent examiner's report

I report to the charity trustees on my examination of the accounts of the charity for the year ended 31st December 2023.

Your attention is drawn to the fact that the charity has prepared financial statements in accordance with Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK (FRS 102) in preference to the Accounting and Reporting by Charities: Statement of Recommended Practice issued on 1 April 2005 which is referred to in the extant regulations but has now been withdrawn.

I understand that this has been done in order for financial statements to provide a true and fair view in accordance with Generally Accepted Accounting Practice effective for reporting periods beginning on or after 1 January 2015.

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

- accounting records were not kept in respect of the charity as required by section 130 of the Act; or
- 2. the accounts do not accord with those records; or
- 3. the accounts do not comply with the applicable requirements concerning the form and content of accounts set out in the Charities (Accounts and Reports) Regulations 2008 other than any requirement that the accounts give a 'true and fair view' which is not a matter considered as part of an independent examination.
